Notice is hereby given in terms of the stipulations of Section 22 of the Local Government Act : Municipal Finance Management, 2003 (Act 56/2003) and Section 75A of the Local Government Act : Municipal Systems, 2000 (Act 32/2000) that the Concept Capital and Operational Budget for the 2009/2010 financial year was tabled on 31 March 2009 and that :-

2. Property rates based on the preliminary valuation roll which will commence on 1 July 2009 will be levied as follows:-

Residential	R 0.011
Commercial	R 0.016
Rural Area	R 0.011

3. Tariffs regarding the following were adjusted as follows:-

Sewerage	9%
Refuse	9%
Water	9%
Electricity	25%
Sundries	9% (Excluding graves)

The abovementioned tariffs are based on the preliminary valuation roll and may be amended depending on the final value of the valuation roll. Tariffs are applicable on Merweville, Nelspoort and Beaufort-West as well as the rural area. Discounts on certain qualifying properties will be made in terms of the Council's ratespolicy.
