NOMINATED SUB-CONTRACT FOR THE CONSTRUCTION OF PEDESTRIAN WALKWAYS (PHASE II) IN BEAUFORT WEST

Bids are invited by the Municipal Manager of BEAUFORT WEST MUNICIPALITY from nominated sub-contractors for the construction of a link road and walkways within the Beaufort West Municipality. The work entails the construction of 2570m x 1,5m wide pedestrian walkways, all in segmented paving and precast kerbing.

It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.

Bid documents will only be available at the compulsory Clarification meeting. Prospective bidders must book their tender documents 2 days before the site inspections at (044) 272 0515.

A compulsory site inspection meeting will be held at the Council Chambers of Beaufort West Municipality, **15 Church Street, Beaufort West** at **14:00** on the **24 February 2012**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 14:10.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
