NOMINATED SUB-CONTRACT FOR THE UPGRADING OF O.R. TAMBO AVENUE

Bids are invited by the Municipal Manager of Beaufort West Municipality for nominated sub-contracts for the upgrading of O.R Tambo Avenue in Beaufort West.

It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.
