**CONTRACT FOR THE UPGRADING OF O.R TAMBO AVENUE**

Bids are invited by the Municipal Manager of Beaufort West Municipality for contracts for the upgrading of O.R Tambo Avenue in Beaufort West.

Local Beaufort West nominated sub-contract tenders (labour only) will also be invited in terms of Council's Supply Chain Management Policy.

It is estimated that tenderers for the major contract should have a CIDB contractor grading designation of 3 CE or higher. Contractors registered as potentially emerging contractors with the CIDB who are registered in one contractor grading designation lower than that required (2 CE PE) and who satisfy the eligibility criteria as stated in Clause F.2.1 in the project document are eligible to submit tenders.

Preference is offered to tenderers who comply with the Preferential Procurement Policy of the Beaufort West Municipality.
