The **BEAUFORT WEST MUNICIPALITY** invites tenders for the provision for the **Supply and Installation of Mechanical and Electrical Pumping Equipment for Beaufort West – Phase 1 & Phase 2**.

Tenderers must be registered with the CIDB and it is estimated that tenderers should have a CIDB contractor grading designation of **3ME** or higher.

Preferences are offered to tenderers who have HDI equity, employ women and disabled persons and are located within the Western Cape Province in terms of the following:

1. Economic empowerment of HDI as published in the Preferential Procurement Regulation, 2001 (Government Gazette No 22549 of 10 August 2001).
2. Supply Chain Management Policy for the Beaufort West Municipality promulgated in terms of Article III, Policy on Municipal Financial Management, 2003 (Act No 56 of 2003).

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders.
