### PUBLIC TRANSPORT INFRASTRUCTURE PROJECT IN NELSPOORT (PHASE II)

Tenders are hereby invited from qualified Civil Engineering Contractors for the construction of Public Transport Infrastructure in Nelspoort.

The work entails the construction of pedestrian sidewalks. It will be expected of the Contractor to make use of labour intensive construction methods.

#### TENDER CONDITIONS:

1. Only tenderers who are currently registered with the CIDB with the necessary grading are eligible to submit tenders. It is estimated that a CIDB grading level of 3 CE or higher will be required.
2. Tender documents will be available at the Offices of the Municipality at 112 Donkin Street in Beaufort West during office hours on the day of the compulsory site inspection. Alternatively, tender documents will be available at the site inspection. **Prospective tenderers must book their tender documents 2 days before the site inspections at the Department of Civil Engineering Services (tel. 023-4148102).**
3. A **non-refundable tender deposit of R350.00**, payable in cash or by bank guaranteed cheque made out in favour of Beaufort West Municipality, is required on collection of the tender documents. **Electronic payment details are Beaufort West Municipality, ABSA Bank, account nr. 4050538936, branch code 632005, current or cheque account.**
4. Tenders may only be submitted on the tender document that is issued. All information on the preferential points claim form and terms of reference must be completed. Prospective tenderers of which the preferential points claim form and terms of reference are not completed, will not be considered for preferential and terms of reference points.
5. A valid, Original Income Tax Clearance Certificate, obtainable from SARS, as well as proof of payment of regional services levies must accompany the tender.

7. **A compulsory site/information session will be held on 30 June 2011, at 11:00 at the Library in Nelspoort. All prospective tenderers are to meet at the said date, time and place.**

The tender must be placed in a sealed envelope, clearly marked on the outside with the tender number, project name and directed to **The Municipal Manager**, and deposited in the official tender box, at **112 Donkin Street, Beaufort West, before closing time on closing date.** Office hours: 07:30 to 16:00, Monday to Friday.
9. **The tender closure date and time, shall be Friday 15 July 2011 at 14:00.**
10. All prices tendered must include VAT.
11. Tenders will be opened in the Conference room, Municipal Offices, 112 Donkin Street, Beaufort West in public, immediately after the closing time at 14:00.
12. Tenders not conforming to the aforementioned conditions shall be rejected.
13. The lowest or any tender shall not necessarily be accepted and the Council reserves the right to accept any part of a tender.
14. The tender shall be evaluated and allocated in terms of the Council's Supply Chain Management and Procurement Policy.
