PART T1.1: TENDER NOTICE AND INVITATION TO TENDER

**Tenders for nominated sub-contracts** are hereby invited in terms of Chapter 11 of the Municipal Financial Management Act, 2003 (Act 56 of 2003) for the upgrading of Streets in Murraysburg, Phase 1 for Beaufort West Municipality.

It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.

Preference is offered to tenderers who comply with the Preferential Procurement Policy of the Beaufort West Municipality.

Documents will only be available for collection at the compulsory site meeting if tenderers booked their tender documents 2 days before the site inspection at Trucon (Tel no. (023) 414 3382).

A non-refundable tender deposit of R 114.00 payable in cash (only at the site inspection) or by bank guaranteed cheque made out in favour of the Employer is required on collection of the tender documents.

A compulsory site inspection meeting with representatives of Employer will take place in the Murraysburg Council Chambers at the municipal offices in Beaufort Street, Murraysburg, on **Thursday 22 September 2011** starting at **12:00**. Only tenderers who attend the compulsory site inspection are eligible to submit tenders. **No tenderers will be allowed to attend the compulsory site inspection meeting after 12:10.**

The closing time for receipt of tenders is **14:00** on **Friday 7 October 2011**. Sealed tenders, endorsed with the corresponding tender notice number and description, must be placed in tender box at the offices of **Beaufort West Municipality, 1 Sanlam Building, Reception at Municipal Offices, 112 Donkin Street, Beaufort West not later than 14:00 on 7 October 2011**, after which tenders will be opened in public. Telephonic, electronic, facsimile, and late tenders will not be accepted.

Tenders may only be submitted on the tender documentation that is issued.
