CONTRACT FOR THE UPGRADING OF PETUNIA STREET

PART T1.1: TENDER NOTICE AND INVITATION TO TENDER

Tenders are hereby invited in terms of Chapter 11 of the Municipal Financial Management Act, 2003 (Act 56 of 2003) for the upgrading of Petunia Street in Beaufort West.

Local Beaufort West nominated sub-contract tenders (labour only) will also be invited in terms of Chapter 11 of the Municipal Financial Management Act, 2003 (Act 56 of 2003).

It is estimated that tenderers for the major contract should have a CIDB contractor grading designation of 3 CE or higher. Contractors registered as potentially emerging contractors with the CIDB who are registered in one contractor grading designation lower than that required (2 CE PE) and who satisfy the eligibility criteria as stated in Clause F.2.1 in the project document are eligible to submit tenders.

Preference is offered to tenderers who comply with the Preferential Procurement Policy of the Beaufort West Municipality.

A non-refundable tender deposit of R 350.00 payable in cash (only at the site inspection) or by bank guaranteed cheque made out in favour of the Employer is required on collection of the tender documents.

A compulsory site inspection meeting with representatives of Employer will take place at the offices of Beaufort West Municipality in 61 Bird Street on **Thursday 22 July 2010** starting at **11:00 am**. Only tenderers who attend the compulsory site inspection are eligible to submit tenders. **No tenderers will be allowed to attend the compulsory site inspection meeting after 11:10 am.**

The closing time for receipt of tenders is **14:00 on Friday 6 August 2010**. Sealed tenders, endorsed with the corresponding tender notice number and description, must be placed in tender box at the offices of **Beaufort West Municipality, 1 Sanlam Building, Reception at Municipal Offices, 112 Donkin Street, Beaufort West not later than 14:00 on 6 August 2010**, after which tenders will be opened in public. Telephonic, electronic, facsimile, and late tenders will not be accepted.

Tenders may only be submitted on the tender documentation that is issued.
