NOMINATED SUB-CONTRACT FOR THE UPGRADING OF STREETS AND INTERSECTIONS IN THE BEAUFORT WEST INDUSTRIAL AREA, PHASE 2

Tenders for nominated sub-contracts are hereby invited in terms of Chapter 11 of the Municipal Financial Management Act, 2003 (Act 56 of 2003) for the upgrading of streets and intersections in the Beaufort West Industrial area, Phase 2.

It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.

Preference is offered to tenderers who comply with the Preferential Procurement Policy of the Beaufort West Municipality.

A non-refundable tender deposit of **R 228.00** is payable in cash, electronic transfer or by bank guaranteed cheque made out in favour of the Employer. **All payments for the documents must be paid at the municipal cashiers in Church Street, Beaufort West and a municipal receipt or an original electronic payment confirmation is required on collection of the tender documents. The closing time for receipt of tenders is **14:00** on **Friday 8 April 2011**. Sealed tenders, endorsed with the corresponding tender notice number and description, must be placed in tender box at the offices of **Beaufort West Municipality, 1 Sanlam Building, Reception at Municipal Offices, 112 Donkin Street, Beaufort West, not later than 14:00 on Friday 8 April 2011**, after which tenders will be opened in public. Telephonic, electronic, facsimile, and late tenders will not be accepted.

Tenders may only be submitted on the tender documentation that is issued.
