**Tenders for nominated sub-contracts** are hereby invited in terms of Chapter 11 of the Municipal Financial Management Act, 2003 (Act 56 of 2003) for the upgrading of Petunia Street in Beaufort West.

**It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.**

Preference is offered to tenderers who comply with the Preferential Procurement Policy of the Beaufort West Municipality.
