3. Quotations, which are late, incomplete, unsigned or submitted by facsimile or electronically, will not be accepted;
4. **Price(s) quoted must be firm, valid for three months and must be inclusive of VAT**
5. **This quotation will be evaluated in terms of the 80/20 preference point system and for this purpose quotation documents must be scrutinised. (Copies of detailed specifications together with the quotation documents are obtainable at the Electricity Department at Beaufort West Municipality, Loch Road, Beaufort West.)**
6. Preference will be given to suppliers based within the Beaufort West area;
7. An original current Tax Clearance from SARS must be attached to the quotation.
8. Copy of the EE1 CIDB must be attached to the quotation. Failure to attach the CIDB will result in disqualification of the prospective service provider. (Grade 1)
