(F) - Peak Month Factor: Maximum value calculated from July 2019 to June 2024 data.

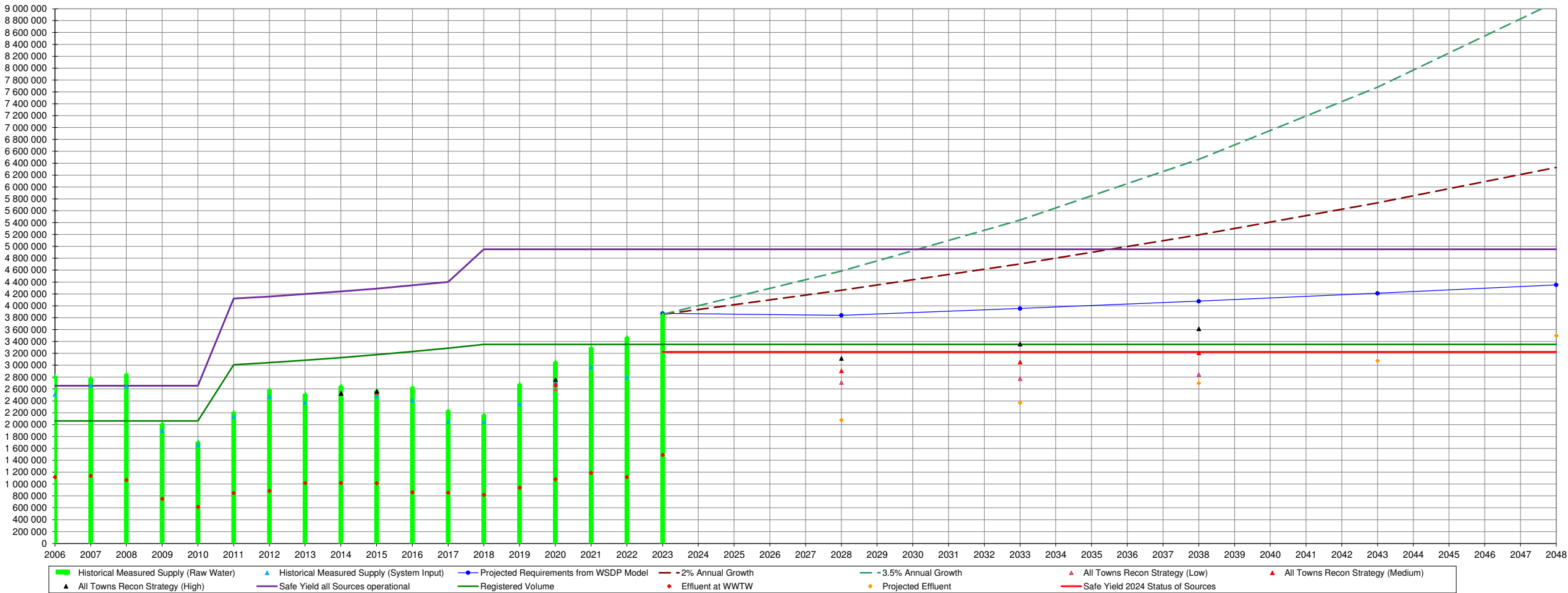
