**ARRANGEMENTS FOR UNBLOCKING AND RECONNECTION OF ELECTRICITY
METERS DURING OFFICE EASTER HOLIDAYS**

The Community is herewith notified that Credit Control and Debt Collection measures will be implemented on the **17th of April 2025**. Property owners, Indigent, Domestic and Business Consumers who have an outstanding balance on their municipal accounts are urged to enter repayment arrangements to settle debt over an extended period.

Effective February 2025, unblocking of prepaid meters are automated by method of payment at a municipal cash office, no after hour assistance is available. Therefore, arrangements to unblock a meter must be made before **Thursday, 17 April 2025 at 16h00** or settlement of a municipal account must be done at a cash office during operational hours. All EFT and Easypay consumers must ensure that payment of municipal accounts must be reflected in the municipal account by latest 16 April 2025 to ensure payments are processed on the municipal account this will allow for uninterrupted prepaid electricity purchases.

All residents within the Beaufort West Municipal Area are urged take note of the office closure and plan their business accordingly.

Alle EFT –en Easypay verbruikers moet verseker dat betaling van munisipale rekeninge teen 16 April 2025 in die munisipale rekening gereflekteer moet word om te verseker dat betalings op die munisipale rekening verwerk word, dit sal voorsiening maak vir ononderbroke voorafbetaalde elektrisiteitsaankope.
