### PROCEDURES FOR CONFIDENTIAL REPORTING OF FINANCIAL MISCONDUCT AND FINANCIAL OFFENCES.

In terms of Section 17 (1) of the Local Government Municipal Finance Management Act, 2003: Municipal Regulations on Financial Misconduct Procedures and Criminal Proceedings, gazette no 37682 of 30 May 2014, the Municipality must establish procedures for reporting of financial misconduct.

*17. (1) A municipality must-*

- (a) establish reporting procedures for persons to report allegations of Financial misconduct and financial offences on a confidential basis; and*
- (b) make public the reporting procedures in accordance with section 21(1)(a) and (b) of the Municipal Systems Act.*

Section 21(1) (a) and (b) of the Local Government Municipal Systems Act, 2000 states the communication of the local community as follows:

*Communications to local community*

*21. (1) When anything must be notified by a municipality through the media to the local community in terms of this Act or any other applicable legislation, it must be done—*

- (a) in the local newspaper or newspapers of its area;*
- (b) in a newspaper or newspapers circulating in its area and determined by the council as a newspaper of record;*

In terms of the Council approved Integrity Management Framework the following procedures has been established by the Beaufort West Municipality:

#### **Reporting of allegations of financial misconduct in terms of the municipal regulations on financial misconduct procedures and criminal proceedings section 3**

The regulation prescribes to whom a person must report an allegation of financial misconduct.

A staff member or councillor or member of the public can report allegations of fraud or corruption anonymously as follows:

- If against accounting officer (MM), chief Financial officer (Director Financial Services) or senior manager<sup>1</sup> (Directors) the matter must be reported to Council, Provincial and National Treasury.
- If against any other official the matter must be reported to the Accounting Officer –

- If against the Accounting Officer (MM) the matter must be reported to the Mayor –  
[bwmmayor@beaufortwestmun.co.za](mailto:bwmmayor@beaufortwestmun.co.za)
- The allegation *must* be submitted to the municipal council within seven days or at the next sitting of Council

Allegations of financial misconduct must be treated in a confidential manner.

Ingevolge Artikel 17 (1) van die Wet op Plaaslike Regering Municipale Finansiële Bestuur, 2003: Municipale Regulasie oor Finansiële Wangedragprosedures en Strafregtelike Verrigtinge, Koorant no 37682 van 30 Mei 2014, moet die Munisipaliteit procedures vir die rapportering van finansiële wangedrag daarstel.

17. (1) 'n Munisipaliteit moet-

- (a) aanmeldings prosedures daarstel vir persone om bewerings van Finansiële wangedrag en Finansiële misdrywe op 'n vertroulike basis aan te meld,
- (b) die verslaadoenings prosedures ooreenkomsdig artikel 21(1)(a) en (b) van die Municipale Stelselwet openbaar maak..

Artikel 21(1) (a) en (b) van die Wet op Plaaslike Regering Municipale Stelsels, 2000 stel die kommunikasie van die plaaslike gemeenskap soos volg:

*Kommunikasie aan plaaslike gemeenskap*

21. (1) Wanneer enigets deur 'n munisipaliteit deur die media aan die plaaslike gemeenskap in kennis gestel moet word ingevolge hierdie Wet of enige ander toepaslike wetgewing, moet dit gedoen word-

- (a) in die plaaslike koerant of koerant van sy gebied;
- (b) in 'n koerant of koerant wat in sy gebied sirkuleer en deur die raad as 'n rekord koerant bepaal is:

Ingevolge die Raad-goedekeurde Integriteits Bestuurs Raamwerk is die volgende prosedures deur die Beaufort-Wes Munisipaliteit vasgestel:

#### **Rapportering van bewerings van finansiële wangedrag ingevolg die municipale regulasies oor finansiële wangedrag prosedures en strafreglike prosedures artikel 3**

Die regulasie skryf voor aan wie 'n persoon 'n bewering van finansiële wangedrag moet rapporteur.

'n Personeellid of Raadslid of lid van die publiek kan bewerings van bedrog of korruksie anoniem soos volg rapporteur:

- Indien teen Rekenpligtige beampte (MB), hoof Finansiële Beampte (Direkteur Finansiële Dienste) of Senior Bestuurders (Direkteure) moet die aangeleentheid by die Raad, Provinciale en Nasionale Tesourie aangemeld word.
- Indien die aangeleentheid teen enige ander amptenaar gerapporteer word, moet dit by die Rekenpligtige Beampte – [derickw@beaufortwestmun.co.za](mailto:derickw@beaufortwestmun.co.za) of Interne Oudit-[roneln@beaufortwestmun.co.za](mailto:roneln@beaufortwestmun.co.za) of gebruik gemaak word van die nasionale bedrog-blitslyn-**0800 701 701**
- Indien teen die Rekenpligtige Beampte (MB) moet die saak by die Burgemeester aangemeld word– [bwmmayor@beaufortwestmun.co.za](mailto:bwmmayor@beaufortwestmun.co.za)
- Die bewering moet binne sewe dae of by die volgende sitting van die Raad by die municipale raad ingedien word.
