

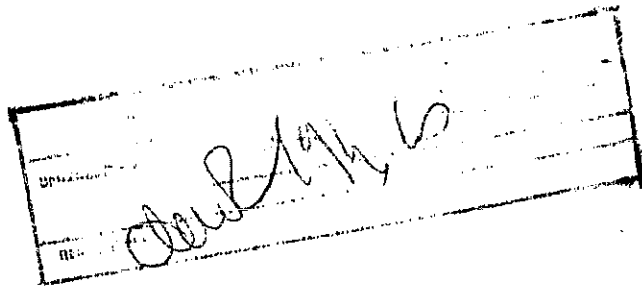



Kinnearson on 18 September 1864 and subsequent Deeds of Transfer the last of which made in favour of the Appearer's Constituent and the said Matthys Johannes Weeber on 14 April 1891 will more fully point out and further subject to such conditions as are therein mentioned or referred to.

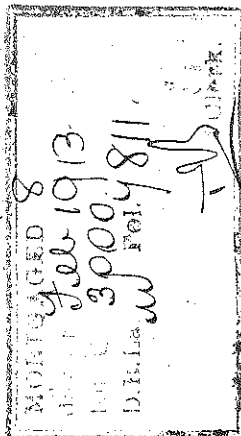
