Quotations received in electronic format or after the closing time and date will not be considered. Council is not bound to accept the lowest or any quotation. Telegraphic, telephonic, telex, facsimile, e-mail and late quotations will not be accepted

The quotation must be valid for a period of 90 days after the closing date. The quotation will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
