**UPGRADING OF VOORTREKKER AND PASTORIE INTERSECTION IN MURRAYSBURG**

The BEAUFORT WEST MUNICIPALITY hereby invites quotations for the upgrading of Voortrekker and Pastorie Intersection in Murraysburg. The scope of works consists of the construction of approximately 984 m<sup>2</sup> (0.0587 km) Road.

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation **of 1CE or higher**. A prerequisite of 60% exist for functionality.

Quotations received in electronic format or after the closing time and date will not be considered. Council is not bound to accept the lowest or any quotation. Telegraphic, telephonic, telex, facsimile, e-mail and late quotations will not be accepted

The quotation must be valid for a period of 90 days after the closing date. The quotation will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011. The 80/20 preference points system will be applicable.
