Bids are invited by the **Municipal Manager of Beaufort West Municipality** for the Supply and installation of Mechanical and Electrical Borehole Pumping Equipment for Nelspoort.

A prerequisite of 70% exist for Functionality, in order to be further evaluated.

It is estimated that tenderers should have a CIDB contractor grading designation of 3 ME or higher. Contractors registered as potentially emerging contractors with the CIDB who are registered in one contractor grading designation lower than that required (2 ME) and who satisfy the eligibility criteria as stated in Clause F.2.1 in the project document are eligible to submit tenders.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
