The BEAUFORT WEST MUNICIPALITY hereby invites Building contractors for the Construction of Ablution block (Basketball) at the Kwa-Mandlenkosi Sports Grounds.

It is estimated that the contractor should have a CIDB contractor grading designation of 2GB or higher. A prerequisite of 60% exist for functionality.

A **compulsory site inspection meeting** will be held at the **Office of Director: Engineering Services** in **61 Bird Street in Beaufort West** at **14:00 on 09 December 2015**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 14:10.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
