Bids are invited by the Municipal Manager of BEAUFORT WEST MUNICIPALITY for **SCM 14/2017: CONTRACT FOR THE CONSTRUCTION OF A NEW CASHIER OFFICE**. The scope of works consists of the construction of a new electricity pay office with a gross construction area of approximately 87m².

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of **3 GB or higher and a prerequisite of 65% exist for Functionality**.

A compulsory site inspection meeting will be held at the **Beaufort West Youth Hub, Ngesi Avenue, Kwa-Mandlenkosi, Beaufort West** at **11:00** on the **24 November 2016**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 10 minutes after the meeting commenced.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
