The Beaufort West Municipality hereby invites Consulting Engineering Services for the upgrading and extension of all reticulation, bulk water services and water sources within the jurisdiction area of Beaufort West Municipality which includes the towns of Beaufort West, Murraysburg, Nelspoort and Merweville for a period of 3 years.

**A prerequisite of 75% exist for functionality, in order to be evaluated on price and preference points.**

No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (thirty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
