Bids are invited by the Acting Municipal Manager of the BEAUFORT WEST Municipality for the supply and delivery of tyres, tubes, wheel alignment and tyre repair services for a period of **36 months**.

Documents will **ONLY** be available to prospective bidders who attend the meeting. Tender documents must be reserved at least **1 working day** before the pre-tender clarification meeting. **Hard copies of Tender documents must be reserved by Tuesday, 18 November 2025 before 14:00 and will only be available at the compulsory clarification meeting.** No tenderers will be allowed to attend the compulsory clarification meeting after 11:15.

Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in black ink by hand and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and Beaufort West Municipality reserves the right to accept any part of the bid.

The tender must be valid for a period of **120** (one hundred and twenty) days after the closing date.

The tender will be subject to Council's Supply Chain Management and Preferential Procurement Policies. The 80/20 preference points system will be applicable. A maximum of 80 points will be awarded for Price and a maximum of 20 points will be awarded for the following Specific Goals:
