**UPGRADING OF KLEIN HANS RIVIER SCHEME: PHASE 1**

Bids are invited by the Municipal Manager of Beaufort West Municipality for **Upgrading of the Klein Hans River Scheme: Phase 1**. The proposed scope of work include the construction of a water pipeline with associated fittings.

It is estimated that the Tenderers should have a CIDB contractor grading designation of **6CE or higher for the main contractor and 3ME or higher for his subcontractor. A prerequisite of 75% exist for functionality, in order to be further evaluated.**

**The work entail the construction of a new 160 and 200 mm dia uPVC rising main  $\pm$  3000 m long, and the upgrading of an existing pump station which will include new pumps, mechanical, electrical and enlarging the pipe infrastructure within.**

Documents will only be available for collection at the compulsory site inspection meeting if tenderers booked their tender documents in advance 2 days before the site inspection. Any person desiring to be present may attend.

A compulsory site inspection meeting will be held at the Offices of the Director: Engineering Services, 61 Bird Street, Beaufort West at **11:00 on the Thursday, 19 October 2017**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 10 minutes after the meeting commenced.**

It is expected of all prospective service providers who are not yet registered on the CSD to register without delay on the prescribed form. The Municipality reserves the right not to award tenders to prospective suppliers who are not registered on the CSD.

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. Tenders shall be evaluated in accordance to Method 2 of the CIDB tender evaluation methods. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017.
