REQUEST FOR PROPOSALS: IMPLEMENTING AGENT TO SOURCE FUNDING FOR IMPLEMENTATION OF INFRASTRUCTURAL PROJECTS

Beaufort-West Local Municipality is currently calling for proposals to source for Turn Key Implementing Agents that will source grant funding or specific purpose allocations to finance and implement the development of infrastructure and other services for the municipality. Formal proposals are hereby invited to bid and propose the best models of funding and implement the projects that will have Local Economic spinoffs and projects that will support the Local Economic Development of Beaufort-West Local Municipality. Contract is for a 3 year period with option to extend to complete project started before contract expiring date.

These will target specific allocations but not limited to the following:

- (a) Upgrade of internal Roads and Storm water;
- (b) Refurbishment of existing water and sewer reticulation network;
- (c) Upgrade of sewer treatment plants;
- (d) Bulk electrical supply and renewable energy

The bidders will not be restricted to apply for one grant however the municipality will consider all bids and may appoint more than one bidder depending on the proposals received. The appointment of the service provider will be at its own risk. The appointed service provider will be expected to acquire funding for the implementation of various infrastructure programs within the municipality without any payment from the municipality. Payment from the municipality will only be done once the funding has been acquired and according to terms of the signed SLA by both parties. Contracts terms and conditions will be negotiated upon selection of the winning bidder. **A prerequisite of 60% exist for Functionality.**

Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room at the Supply Chain Management Unit at the Sanlam Building, Donkin Street, Beaufort West.

A compulsory clarification meeting will be held at **the conference room of the Electro-Technical Services; Loch Road, Beaufort West** at **11:00 on day, 13 September 2019**. **No tenderers will be allowed to attend the compulsory clarification after 11:15.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 120 (one hundred and twenty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2017. The 90/10 preference points system will be applicable.
