Bids are invited by the Municipal Manager of Beaufort West Municipality for tender the Refurbishment of Tennis Courts in Beaufort West.

The work entails the refurbishment of six tennis courts.

It is a requirement that **Tenderers have an estimated minimum CIDB grading of 2CE and/or 2SB.**

Tenderers will have to **confirm successful similar previous experience** in the construction and/or refurbishment of **tennis/netball courts surfaces**. Tenderers not able to confirm successful similar previous experience will not be considered for this Tender.

**Tenderers will also be required to submit their own quality control procedures.** Tenderers not able submit any quality control procedures will not be considered for this Tender.

Documents will only be available for collection at the compulsory site inspection meeting if tenderers booked their tender documents in advance 2 days before the site inspection. Any person desiring to be present may attend.

A compulsory site inspection meeting will be held at the **Offices of the Acting Director: Engineering Services, 61 Bird Street, Beaufort West** at **11:00** on the **10 December 2018**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 11:15.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

It is expected of all prospective service providers who are not yet registered on the CSD to register without delay on the prescribed form. The Municipality reserves the right not to award tenders to prospective suppliers who are not registered on the CSD.

The bid must be valid for a period of 90 (ninety) days after the closing date. Tenders shall be evaluated in accordance to Method 2 of the CIDB tender evaluation methods. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017.
