Bids are invited by the Municipal Manager of BEAUFORT WEST MUNICIPALITY for the **high mast and street lighting projects for the period ending March 2021**. The scope of works consists of the supply, delivery, erection, commissioning and maintenance of high mast and street lighting projects within Beaufort West Municipal area for a period of 3 years.

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of **5EP or higher**.

Documents will only be available for collection at the compulsory site inspection meeting if tenderers booked their tender documents in advance 2 days before the site inspection. A compulsory site inspection meeting will be held at the **Offices of the Director: Electro Technical Services, Loch Road, Beaufort West** at **11:00 on Thursday, 8 March 2018**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 11:10.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. Local content requirements is 100% and 90% applicable to bid document.
