The BEAUFORT WEST MUNICIPALITY hereby invites suitably qualified service providers to bid for the **NOMINATED SUB-CONTRACTOR FOR THE NEW & UPGRADE OF STORM WATER DRAINAGE**, **MEIRING & LEEB STREET**, **MURRAYSBURG**. The scope of the work consists of the construction of new and upgrading of existing stormwater drainage, depending on tender prices.

It is estimated that the sub-contractor should have a CIDB contractor grading designation of 1CE or higher. It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.

No tenderers will be allowed to attend the compulsory clarification meeting after 14:15.

A non-refundable fee of R150.00 (One hundred and Fifty Rand), is payable for a set of printed documents. Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Bids received in electronic format or after the closing time and date will not be considered. Council is not bound to accept the lowest or any Bid. Telegraphic, telephonic, telex, facsimile, e-mail and late Bids will not be accepted.

Bids must be submitted on the original documents and must be valid for a period of 120 days after the closing date. The Bid will be subject to Council's Supply Chain Management Policy, the Amended Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
