The BEAUFORT WEST MUNICIPALITY hereby invites suitably qualified service providers to bid for the the supply, delivery, rigging, installation, detailed commissioning, taking-over and maintenance inspections for a standby generating set, by a dedicated specialist supplier, adjacent to the existing Beaufort West Water Treatment Works. This project's scope of works is summarised as follows:

1 x New outdoor standby generating set, complete with plinth, sleeves and all required cable work. Biannual maintenance of the set during the retention period.

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of 2EB or 2EP or higher.

Bids received in electronic format or after the closing time and date will not be considered. Council is not bound to accept the lowest or any Bid. Telegraphic, telephonic, telex, facsimile, e-mail and late Bids will not be accepted.

Bids must be submitted on the original documents and must be valid for a period of 90 days after the closing date. The Bid will be subject to Council's Supply Chain Management Policy, the Amended Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
