The BEAUFORT WEST MUNICIPALITY hereby invites contractors to submit formal written quotations for the removal of asbestos roof and replacement of roof sheets and rainwater goods at the Thusong Centre.

It is estimated that the contractor should have a CIDB contractor grading designation of 1GB or 1CE higher.

No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced.

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (thirty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
