The Beaufort West Municipality hereby invites qualified Civil Consulting Engineers to provide services for detailed design, tender specifications/documentation, contract administration, construction supervision and monitoring of roads and storm water infrastructure and the construction of new paved roads which may include green fields, wetland, rezoning as well as the accompanied storm water drainage for Beaufort West Municipality, for a period of 3 years.

A prerequisite of 70% exist for functionality, in order to be evaluated on price and preference points.

No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced.

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (thirty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
